I. Before You Start at UM  
a. Important Information

Prior to starting at the University of Miami, there will be several steps that you need to take as an international exchange student. As an international exchange student, you will need to demonstrate your proficiency in English if you are not currently in a program being taught in English. One way to demonstrate your proficiency is by taking the Test of English as a Foreign Language (TOEFL).

In order to attend the University of Miami law school as a foreign student, you will first need to obtain a student visa and be able to demonstrate that you have sufficient funds to provide for the educational and personal expenses you will incur during your semester of study in the United States.

International exchange students must obtain an F-1 or J-1 visa in order to seek admission to the U.S. for full-time studies, unless you are a citizen of Canada or Bermuda. To apply for an F-1 visa, you must provide the U.S. Embassy or Consulate with Form I-20 (for F-1 students), your passport, a statement of funds, and other documents as required by the U.S. Embassy or Consulate. Miami Law international exchange students will be contacted by the Executive Liaison for Interdisciplinary Programs regarding what is needed for visa purposes.

b. Costs

International exchange students attending Miami Law for one semester pay tuition to their home institutions. However, there are a number of costs besides tuition that students need to consider when budgeting for law school, such as housing, food, transportation, etc. The link below will show the estimated costs of the most common expenses law students come across. c. Immunization and Health Insurance

All international students are required to enroll in the university-sponsored health insurance program. The insurance policy is charged to students at the annual premium (pro-rated for the semester) rather than monthly.

If a student already has alternate health insurance coverage, they may submit the International Student Health Insurance

Compliance Form (which can be obtained from the Student Health Center) along with a copy of the alternate health ID card and coverage policy in English with an itemized summary of benefits showing that the plan is of equal or greater value of the university's health insurance for review and approval to waive the annual health insurance fee. Also include the US claims agent's contact information for the international health insurance plan.

The cost of health insurance (unless waived) and the fee for Student Health and Counseling will be added to each student's account.

All students are required to provide proof of immunization against measles, mumps and rubella and must also provide proof of immunization against hepatitis B and meningococcal meningitis or sign a waiver declining these immunizations. In addition, all international students must be screened for tuberculosis within six months prior to arrival on campus, or by one month after arrival on campus and by completing page two of the immunization form. Kindly submit them in English. Students who believe that they were previously immunized but are unable to provide proof of immunization may either obtain blood tests confirming immunity or obtain the necessary immunizations. Immunizations and blood tests documenting immunity are available at the Student Health Center.

d. Housing

The University of Miami is situated in the heart of Coral Gables and surrounded by an abundance of housing options. From Red Road Commons directly across the street from the university to Axis in the Brickell area or Gables Point in South Miami, there are a variety of rental possibilities to meet your needs and budget. When searching for a place to live, prioritize your needs versus your wants and balance all important considerations to come to the decision that suits you best. Please keep in mind that if you will not have a car to drive to and from campus, you will want to choose a housing option that is within walking or bicycling distance from the school or situated where public transportation can be easily accessed. The Miami-Dade Metrorail has a stop at University station, which is right on campus, making it convenient to get to and from school for students living in the Dadeland or Brickell neighborhoods.

e. Obtaining an ID or Drivers License

If you do not plan to operate a motor vehicle while you are living in Florida, you may obtain an identification card that will serve the many purposes for which you may have to present a photo ID. The fee for a Florida ID is \$25. You can find further information regarding the requirements for obtaining an ID at the link below.

If you do plan to drive in the state of Florida, you will need to first obtain a Florida driver's license. The fee for a Florida driver's license is \$48. The Division

of Motor Vehicles (DMV) is usually on the University of Miami campus when the Fall semester begins, making it a convenient opportunity to obtain your driver's license or state ID. You can find further information regarding the requirements for obtaining a driver's license at the link below. Note: There are different requirements for U.S. citizens and Non- U.S. citizens. Please be sure to review the requirements that apply to you.

Your Cane Card is your student identification card. You will obtain your Cane Card shortly after you arrive on campus at the beginning of the semester. You will be required to carry it with you on campus for identification purposes. Your Cane Card can also be used to purchase meals, print and make copies at the library, attend sporting events, and access the Student Wellness Center. f. Course Registration

The University of Miami School of Law tries to offer a wide variety of courses spanning numerous areas of law. You can see what courses are available and read the course descriptions provided by the professors by viewing the Course Description Booklet on the Law Registrar's webpage. The Course Description Booklet also features convenient search functions that allow you to target certain courses by professor, number of credits, keywords in the course title or description, or type of graduation requirement the course fulfills. Prof. Scott Rogers will be advising you regarding course options, and you will register for your courses when you arrive at the University just before the semester begins. #### g. Parking

If you will be driving your own car to and from school as a student, you will need to obtain a parking permit in order to park in the various lots throughout the campus. The lots at University of Miami are designated by color, so where you will be able to park will depend on the color of the pass you purchase. You can purchase a pass for the semester or for the year. There is also a discounted pass available for the Green lot, which is the Ponce garage. If this pass better fits your budget, there are shuttles that transport students throughout the campus. The Ponce/Fountain shuttle will take you from the Ponce garage to the law school. #### h. Public Transportation Options

The University of Miami is conveniently located along the Metrorail. There is a Metrorail exit specifically for the university, making it an extremely convenient option for commuting students who do not live directly on campus or do not have a vehicle for transportation purposes. ## II. Orientation

Orientation is designed to introduce you to the University of Miami environment and familiarize you with the way things work at the law school. You will get to see classrooms, offices, and various law school facilities as well as go around to the different areas on campus you are also most likely to visit, such as the Food Court and the bookstore. Orientation will take place before your classes begin so you can start to get familiar with the school before you get too busy and can take care of anything you still need to settle before the start of the semester, like getting your Cane ID or turning in your immunization records. ## III. Once You Start at UM

### a. Academic Calendar

c. Books

Book lists showing what textbooks are required and/or recommended for each course depending on the professor you are taking it with are released prior to the start of the academic semester. You will be able to access the list and shop for your books before your classes begin. The University of Miami has a bookstore on campus where you can purchase textbooks, study aids, various school supplies, and an array of memorabilia and miscellaneous items. The link to their website is below. Besides the on-campus bookstore, there is also Book Horizons across the street from the university, which also carries the book selection law students would need. d. Email Accounts/Access to School of Law Network/Wireless Printing

When you are enrolled at the University of Miami School of Law, you will be set up with a university email account. You will be able to access the email system by going to [www.law.miami.edu](http://www.law.miami.edu) and clicking on the Student Email link at the bottom-right hand side of the page. You will be prompted to log in. Your username will be your first initial and last name followed by @students.law.miami.edu (i.e., [jdoe@students.law.miami.edu](mailto:jdoe@students.law.miami.edu)), and your password will be your UM ID with a lowercase “c” in front of it (i.e., c01234567). Law students are given 120 UPrint credits every academic year for use on the UPrint printers located in the Law Library and throughout the campus. Black and white copies are \$.05 and color copies are \$.10. Students may conveniently check

their UPrint credit balance on MyUM. If a student needs to add more credits to their UPrint balance, they may add money to their Cane Express account on MyUM. See the link below for more information.

e. Law Library

The University of Miami School of Law boasts one of the largest research facilities in the Southeast with over 630,000 volumes and microforms. At the Law Library, students can check out books, reserve study rooms, use the computer labs, consult the librarians for research assistance, request an interlibrary loan of materials the library doesn't currently carry, attend trainings on legal research databases, and much more. f. Copy Center

The Copy Center (also referred to as the Distribution Center) is located in the Law Library room B207 on the second floor. At the Copy Center, you can request copies of a document to be made, particularly if it is a large quantity of copies and/or a large document itself. You may also be sent there by professors to pick up packets for their class. More often than not, there is a charge for the packets that you have to pick up from the Copy Center. You may submit either cash or check for payment.

g. Dining Services

There is quite a variety of dining available on campus. The law school has a Einstein Bagel shop located directly on the premises. The Food Court is a hop, skip, and a jump away from the law school with several dining options, including Subway, Panda Express, Sushi Maki, and several others.

Students who plan to do the majority of their eating on campus may choose to sign up for a meal plan. There are several meal plans available ranging from 5 meals to 20 meals per week with additional Dining Dollars available to spend at the various dining options available around campus. There are also block meal plans to choose from where you can purchase a number of meals for the semester and use them up at your own rate – 20 meals one week, 5 meals the next week, etc. Follow the link below for more information.

#### h. Wellness Center

The Patti and Allan Herbert Wellness Center is a one-stop shop for many of your recreational, fitness, and wellness needs. You will need to pay to join since you are not paying University of Miami tuition. You will need your Cane Card to enter the facilities. Once inside you will find a fitness room full of equipment, a track for jogging/walking, a swimming pool, basketball courts, tennis courts, group fitness rooms, and much more. There are many group fitness classes to pick from - many free, some paid. These classes are popular and often have limited space so it is a good idea to arrive early so that you can reserve a spot in a class.

**Appendix 1: List of To Do's When You Arrive  
in Miami 8/2017**

- 1. Register for courses, expect to take 11 credits, Law Registrar will register you.**
- 2. Go to Law Library to pick up Westlaw/Lexis passwords from Pam Robin (D138). Note: class information will be on TWEN (Westlaw).**
- 3. Buy books. Recommend Book Horizons, 1110 South Dixie Highway, Coral Gables, phone: 305-665-6161. Tell them Sandy Abraham sent you.**
- 4. Obtain your user id for your email account. Your password is your C-number beginning with a capital C and no dashes. (The email link is on the Law School web page.)**
- 5. Go to the Law School Help Desk in the Library and get your laptop set up including wireless and ask about how to print documents in the library.**
- 6. Go into CaneLink and set up your logonid and password. You will need your C-number and your birthdate. Once the logonid is assigned, please write it down. Use two-digit month and two-digit date of your birthday, a hyphen, and the first two letters of your last name (using an uppercase letter for the first letter) as your initial password. It will then ask you to change your password and to set up several security questions. Then check your account. Please add your local and permanent addresses.**
- 7. Send Sandy Abraham your local address and a cell phone number (if you have one).**
- 8. Go to UM Parking Office (in the McKnight Building, Ponce de Leon Blvd) and obtain your Cane Card.**
- 9. Go to Student Health Office (on campus) and sign up for Health Insurance, and submit immunization documentation.**
- 10. Go to International Student Services (on campus). You need to bring them copies of visa, etc. Also, you will need to complete a session online for ISS.**
