Part I - Faculty member, one of three trial attorneys selected to teach and train Venezuelan attorneys in preparation for the establishment of a public defender system in that government following the revision to the Venezuelan Constitution which for the first time allowed oral advocacy *and* the confrontation of witnesses. The class included one week of intensive lecturing, demonstrations, and small group training. These attorneys were selected to be the first batch of Public Defenders in a system which, heretofore, relied completely upon *pro bono* representation of accused indigent citizens.

Part II - Trainer, hosted and trained Venezuelan attorney=s on how to establish and run a public defender office. Training consisted of several lectures in Washington D.C. with the students followed by a ten day ~~A~~hands-on@ instruction with the students in select cities. The goal was to demonstrate how public defender offices operate internally, how they function as law firms and how they interact with other services in their communities.
